It is a legal document relating to the current standard NZS 5465:2001. Lifestyle Camping NZ Ltd. operates in partnership with the All Points Camping Club of NZ Inc.

This checklist will become your certificate once endorsed by NZ Lifestyle Camping. You will also receive a warrant / window card (affix to left front windows) valid for four (4) years from the date of issue together with a blue vinyl self containment label for the rear of your vehicle.

NZ Lifestyle Camping or All Points Camping Club of NZ management may contact you or the testing officer to clarify any matters. Payment of the processing fee does not guarantee automatic endorsement or passing for self containment of the vehicle being tested.

Steps to follow:

- You should refer to the requirements of the self containment standard and the checklist before getting your vehicle checked. These can be viewed or downloaded at www.allpointscampingnz.org/get-certified
 - Keep all documentation relating to water tanks and **toilets or google the specifications online. There are online calculators available to help calculate the volume of waste containers
 - The checklist **must** be signed by a suitably qualified testing officer or a registered plumber, drainlayer or gasfitter. This is a requirement of the standard. Go to www.allpointscampingnz.org/get-certified for a list of testing officers in your area.
 - Once payment is received we will complete processing your application. If everything is in order issue the window card, blue self containment label and supporting information. (4-5 working days).
 - If you have not received communication from NZ Lifestyle camping within 5 working days please contact us.

Payment and Issue:

We are unable to issue final documentation until we have confirmed a payment for our fees.

If depositing to the bank account or using internet banking please ensure to **enter your vehicle reg. no as the code.**

Our processing fee for maintaining the register and issuing final documentation by courier is \$40.00.

In some situations this fee may be collected by the testing officer / agent.

Note: You will usually be required to pay the Testing Officer / Agent for their time.
